

FOURTH: Article I of said Restated Certificate of Incorporation is hereby deleted in its entirety and replaced with the following:


"ARTICLE I

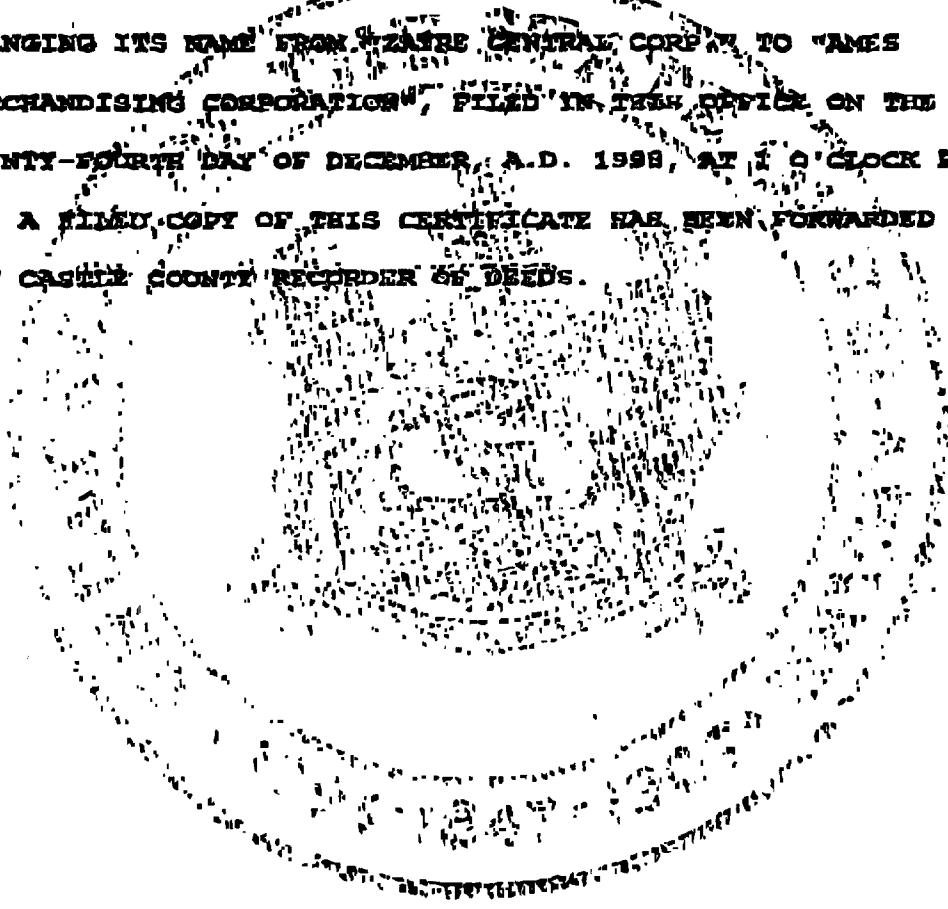
