RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST ("Release"), dated December ²⁹, 1999, is made by Paribas (formerly known as Banque Paribas), a company organized under the laws of France, with an office at The Equitable Tower, 787 Seventh Avenue, New York, New York 10019 ("Paribas").

WITNESSETH:

WHEREAS, Napp Systems, Inc., an Iowa corporation, having its principal office at 360 S. Pacific Street, San Marcos, CA 92069 (the "Company") and Paribas are parties to that certain Amended and Restated Security Agreement dated January 17, 1997 (the "Security Agreement"), which amended and restated in its entirety the Security Agreement dated December 29, 1994 between the Company and Paribas;

WHEREAS, pursuant to the Security Agreement, the Company agreed to assign, convey, mortgage, pledge, hypothecate and transfer to Paribas (on behalf of and for the ratable benefit of the Secured Parties defined therein), and grant to Paribas a security interest in, all Intellectual Property Collateral (as defined in the Security Agreement), including but not limited to the Trademarks listed on Schedule A hereto and the Patents listed on Schedule B hereto, to secure all Obligations (as defined in the Security Agreement) of the Company;

WHEREAS, the Security Agreement was recorded in the indices of the U.S. Patent and Trademark Office on March 3, 1997 at Reel/Frame 1561/0802 and Reel/Frame 8392/0001;

WHEREAS, in connection with the Company's satisfaction of the Obligations, Paribas desires to assign, convey and transfer to the Company, and release its mortgage, pledge and security interest in, the Intellectual Property Collateral, including but not limited to, those Trademarks listed on Schedule A hereto, including all renewals thereof, and the goodwill of the Company's business connected with the use of and symbolized by such trademarks, and the Patents listed on Schedule B hereto, including any continuations, divisions, continuations-in-part, reissues, reexaminations, extensions or foreign equivalents thereof;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Paribas hereby releases the mortgage, pledge and security interest in, and reassigns, conveys and transfers to the Company, any and all right, title and interest which Paribas has in or to the Intellectual Property Collateral, including but not limited to the Trademarks listed on Schedule A hereto and the Patents listed on Schedule B hereto. Paribas agrees that it will execute all such further documents and take such further actions as may be reasonably requested by the Company to carry out the transactions contemplated hereunder.
