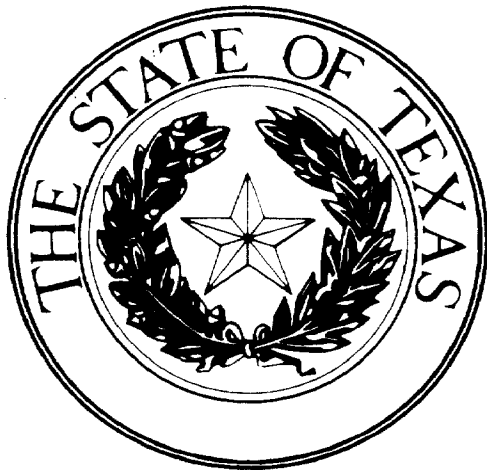



TO THE
ARTICLES OF INCORPORATION

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE ONE: The name of the corporation is A & M Products, Inc.

ARTICLE TWO: The following amendment to the Articles of Incorporation was adopted by the shareholders of the corporation by means of a written consent signed by all shareholders on May 28, 1999, in lieu of a special meeting of shareholders:

Article One of the Articles of Incorporation is hereby amended by deleting the present Article One and by inserting in lieu thereof the following:


ARTICLE ONE

The name of the corporation is The Clorox Pet Products Company.

ARTICLE THREE: The number of shares outstanding is three hundred sixty four (364). The number of shares entitled to vote on the amendment is three hundred sixty four (364).

ARTICLE FOUR: The number of shares voted for and against the amendment respectively were three hundred sixty four (364) and none.
