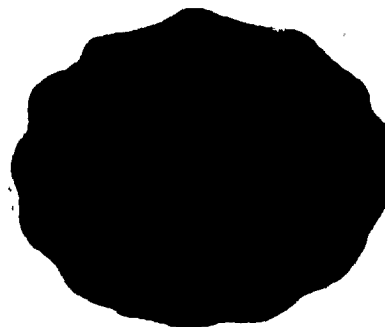

Visser aforementioned, on June 27, 1998, on a draft of which deed the ministerial declaration of no objections was granted on June 26, 1998 under number N.V. 348.845. The deed of the amendment of the articles of association of the Company has become effective as per June 28, 1998;
6. that due to the amendment of the articles of association the name of the Company has been changed into Koninklijke KPN N.V. (also referred to as "Royal KPN N.V.").
