

CERTIFICATE OF INCORPORATION

TAP Holdings Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware,

DOES HEREBY CERTIFY:

FIRST: That the Board of Directors of said corporation, by the unanimous written consent of its members, filed with the minutes of the Board, adopted a resolution in part proposing and declaring advisable the following amendment to the Certificate of Incorporation:

RESOLVED, this Board proposes that on or before April 4, 2000, the Certificate of Incorporation of the Corporation be amended as follows:

Article 1 shall read:

"Article 1. The name of this corporation is TAP Pharmaceutical Products Inc., a close corporation."


RESOLVED, that the Corporation call for a special meeting of this Corporation's shareholders, or for an action in lieu of a meeting, to vote on the foregoing proposed amendment;

RESOLVED, that the Officers of the Corporation be, and hereby are, severally authorized to execute such instruments and to do all other acts as may be necessary in order to effectuate fully the foregoing resolutions, execution of any such instrument by such Officer to be conclusive evidence that the same has been authorized by the foregoing resolutions.

SECOND: That in lieu of a meeting and vote of stockholders, the stockholders have given unanimous written consent to said amendment in accordance with the provisions of Section 228 of the General Corporation Law of the State of Delaware.

THIRD: That the aforesaid amendments were duly adopted in accordance with the applicable provisions of Sections 242 and 228 of the General Corporation Law of the State of Delaware.
