TRADEMARK COLLATERAL ASSIGNMENT AND SECURITY AGREEMENT

THIRD AMENDMENT TO TRADEMARK COLLATERAL ASSIGNMENT AND SECURITY AGREEMENT made as of this 28th day of February, 2000, by and among HANOVER DIRECT, INC., a Delaware corporation, SCANDIA DOWN CORPORATION, a Delaware corporation (each individually an "Existing Debtor" and collectively, "Existing Debtors"), HANOVER BRANDS, INC., a Delaware corporation ("Hanover Brands"), ERIZON, INC., a Delaware corporation ("erizon, inc.") and CONGRESS FINANCIAL CORPORATION, a Delaware corporation ("Secured Party"). Each Existing Debtor, together with Hanover Brands and erizon, inc., shall hereinafter be referred to individually as a "Debtor" and collectively as "Debtors."

WITNESSETH:

WHEREAS, Existing Debtors and Secured Party entered into the Trademark Collateral Assignment and Security Agreement, dated November 14, 1995, as amended by First Amendment to Trademark Collateral Assignment, dated February 22, 1996, and Second Amendment to Trademark Collateral Assignment and Security Agreement, dated September 30, 1998 (the "Trademark Security Agreement"), pursuant to which Existing Debtors granted to Secured Party a security interest in and to the Collateral (as defined in the Trademark Security Agreement); and

WHEREAS, Secured Party, Debtors and certain affiliated companies are contemporaneously herewith entering into the Fourteenth Amendment to Loan and Security Agreement, dated as of the date hereof (the "Fourteenth Amendment to Loan and Security Agreement"), pursuant to which, among other things, Existing Debtors will assign, transfer or convey certain trademarks and trademark applications to either Hanover Brands and erizon, inc. and each of Hanover Brands and erizon, inc. shall be included as a Guarantor under the Financing Agreements pursuant thereto; and

WHEREAS, in order to induce Secured Party to enter into the Fourteenth Amendment to Loan and Security Agreement, Debtors have agreed to enter into this Amendment;

WHEREAS, Hanover Brands and erizon, inc. have together with certain of their affiliates executed and delivered a Guarantee and Waiver, dated as of the date hereof, in favor of Lender (the "Additional Guarantee");

NOW, THEREFORE, in consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Debtors hereby agree as follows:

1. Grant of Security Interest; Collateral Assignment.

As collateral security for the prompt performance, observance and indefeasible payment in full of all of the Obligations (as defined in the Trademark Security Agreement), each of Hanover Brands and erizon, inc. hereby grants to Secured Party a continuing security interest in and a general lien upon, and hereby assigns and transfers to Secured Party: (a) all of Hanover Brands' and erizon, inc.'s now existing or hereafter acquired right, title, and interest in and to: (i) all of Hanover Brands' and erizon, inc.'s trademarks, trade names, trade styles and service marks; (ii) all prints and labels on which said trademarks, trade names, trade styles and service marks appear, have appeared or will appear, and all designs and general intangibles of a like nature; (iii) all applications, registrations and recordings relating to the foregoing in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State thereof, any political subdivision thereof or in any other countries; and (iv) all similar marks or reissues, extensions and renewals thereof, including, without limitation, those trademarks, terms, designs and applications of each of Hanover Brands and erizon, inc. set forth on Exhibit A annexed hereto and made a part hereof (the "Hanover Brands/erizon Amendment Trademarks"); (b) the goodwill of the business symbolized by each of the Trademarks, including. without limitation, all customer lists and other records relating to the distribution of products or services bearing the Trademarks; and (c) any and all proceeds of any of the foregoing, including, without limitation, all rights to income, royalties, damages, any claims by either of Hanover Brands or erizon, inc. against third parties for infringement of the Trademarks or any licenses with respect thereto (all of the foregoing are collectively referred to herein as the "Hanover Brands/erizon Collateral").

2. Amendments to Definitions; Exhibits.

- (a) The following definitions in the Trademark Security Agreement are hereby amended as follows:
- (i) The definition of Debtor and Debtors is hereby amended to include, in addition and not by way of limitation, each of Hanover Brands and erizon, inc., and their respective successors and assigns.
- (ii) The definition of Trademarks is hereby amended to include, in addition and not by way of limitation, the Hanover Brands/erizon Amendment Trademarks.
- (iii) The definition of Collateral is hereby amended to include, in addition and not by way of limitation, the Hanover Brands/erizon Collateral.

- (iv) The definition of Obligations is hereby amended to include, in addition and not by way of limitation, the Obligations of Hanover Brands and erizon, inc. pursuant to the Additional Guarantee executed and delivered by Hanover Brands and erizon, inc. and certain other Guarantors and their Obligations under the Loan Agreement, as amended by the Fourteenth Amendment to Loan and Security Agreement.
- (v) The definition of Guarantees is hereby amended to include, in addition and not by way of limitation, the Additional Guarantee.
- (vi) Exhibits A and B to the Trademark Security Agreement are hereby amended to include the information on Exhibits A and B hereto.
- (b) For purposes of this Amendment, unless otherwise defined herein, all capitalized terms used herein which are defined in the Trademark Security Agreement shall have the meaning given to such terms in the Trademark Security Agreement.
- 3. Special Powers of Attorney. Each of Hanover Brands and erizon, inc. shall, concurrently with the execution and delivery of this Amendment, execute and deliver to Secured Party five (5) originals of a Special Power of Attorney in the form of Exhibit C to the Trademark Security Agreement.
- 4. <u>Effect of this Amendment</u>. Except as expressly amended pursuant hereto, no other changes or modifications to the Trademark Security Agreement or waivers of or consents under any provisions thereof are intended or implied, and in all other respects the Trademark Security Agreement is hereby specifically ratified, restated and confirmed by all parties hereto as of the effective date hereof. To the extent any term or provision of this Amendment conflicts with any term or provision of the Loan Agreement, as amended by the Fourteenth Amendment to Loan and Security Agreement, the term or provision of the Loan Agreement, as amended by the Fourteenth Amendment to Loan and Security Agreement, shall control.
