Assignee shall be solely responsible for preparing and filing all additional documentation (including but not limited to any and all affidavits, declarations, oaths, assignments and powers of attorney) as may be required to perfect or record the assignments of the Marks with the United States Patent and Trademark Office and equivalent offices and agencies in other countries or political subdivisions thereof.
