
WHEREAS, the Assignee is desirous of acquiring the Trademarks, the registrations therefor, and the business and goodwill of the business in connection therewith.

This Assignment of Trademarks is subject to that certain Trademark Purchase Agreement by and between the parties, dated as of the date hereof.




