It is hereby certified that:

First: The name of the corporation is: CHEMICAL MANUFACTURERS ASSOCIATION, INC.

SECOND. The Certificate of Incorporation (Certificate of Consolidation) of the corporation was filed by the Department of State, Albany, New York, on the 22nd day of June, 1950. under the original name of: MANUFACTURING CHEMISTS' ASSOCIATION, INC.

THIRD: The corporation was formed under the Membership Corporations Law.

FOURTH. The corporation is a corporation as defined in subparagraph (a) (5) of Section 102 of the Not-for-Profit Corporation Law.

FIFTH: The corporation is a Type A corporation under Section 201 of the Not-For-Profit Corporation Law.

SIXTH. The amendment to the Certificate of Incorporation (Certificate of Consolidation) effected by this Certificate of Amendment is to change the name of the corporation to the American Chemistry Council, Inc.

SEVENTH. To accomplish the foregoing amendment, Article SECOND of the Certificate of Incorporation (Certificate of Consolidation), relating to the name of the corporation, is hereby amended to read as follows:

"SECOND: The name of the corporation is American Chemistry Council, Inc."

EIGHTH. The foregoing amendment of the Certificate of Incorporation (Certificate of Consolidation) of the corporation was authorized at a meeting at which a quorum of the members entitled to vote thereon was present, by a majority vote as provided in paragraph (c) of Section 613 of the Not-For-Profit Corporation Law of the members of the corporation entitled to vote on the said amendment.
