

CERTIFICATE OF AMENDMENT

OF

THE CERTIFICATE OF INCORPORATION

OF

CBS INC.

Under Section 805 of the Business Corporation Law of the State of New York

We, the undersigned, being the vice president and treasurer and an assistant secretary, respectively, of CBS Inc., hereby certify that:

FIRST: The name of the Corporation is CBS Inc. The name under which the Corporation was formed is United Independent Broadcasters, Incorporated.

SECOND: The original Certificate of Incorporation of said Corporation was filed by the Department of State of the State of New York on January 27, 1927 and was most recently restated on December 8, 1995.

THIRD: Article 1 of the Certificate of Incorporation, which specifies the name of the Corporation, is hereby amended to read as follows:


"The name of the Corporation is CBS Broadcasting Inc."

FOURTH: The last sentence of Article 5 of the Certificate of Incorporation, which specifies the address to which the Secretary of State shall mail a copy of process against the Corporation served upon the Secretary of State, is hereby amended as follows:



FIFTH: The foregoing amendment of the Certificate of Incorporation was approved by the Board of Directors of the Corporation by unanimous written consent in lieu of a meeting on November 11, 1997 and by a written consent of the Corporation's sole shareholder dated November 11, 1997.
