Reference is made to the Disclosure Statement Concerning Debtors' First Amended and Restated Joint Plan of Reorganization Pursuant to Chapter 11 of the United States Bankruptcy Code of Maidenform Worldwide, Inc. ("MFWW"), Maidenform, Inc. ("Maidenform") and NCC Industries, Inc. ("NCC") (the "Disclosure Statement"), the Amended and Restated Loan Agreement dated December 20, 1996, as amended among MFWW and its Subsidiaries, the banks party thereto, and CoreStates Bank, N.A. as Collateral Agent (the "Pre-Petition Loan Agreement") and the Debtor-in-Possession Credit Agreement dated July 22, 1997 among MFWW, Maidenform, NCC and CoreStates Bank, N.A., as Agent (the "DIP Credit Agreement").

The undersigned, being the Agent under the Pre-Petition Loan Agreement and the DIP Credit Agreement (the "Facilities"), hereby agrees that upon the occurrence of the Effective Date (as defined in the Disclosure Statement) the payment of all principal, interest and other amounts outstanding under or in respect of the DIP Credit Agreement (including outstanding letters of credit) and the repayment or replacement of all outstanding standby letters of credit issued under the Institutional Lender Agreements (as defined in the Disclosure Statement) and related agreements and the DIP Credit Agreement, the undersigned hereby (i) releases each of MFWW, Maidenform and NCC and their respective affiliates from any and all obligations it may have under the Pre-Petition Loan Agreement or the DIP Credit Agreement or any of the Security Documents referred to below, (ii) hereby releases any and all liens, charges, encumbrances, mortgages, or security interests granted to it in connection with the Facilities, including without limitation those granted under the documents listed on Annex A hereto (the "Security Documents") and (iii) hereby acknowledges that any Tri-Party Agreement entered into among Maidenform, the undersigned and any bank in which Maidenform has a deposit account is terminated.

The undersigned also agrees to deliver to Maidenform any and all stock certificates, notes or instruments currently in its possession delivered pursuant to the Security Documents or otherwise.

The undersigned also agrees to execute and deliver to Maidenform any and all termination statements, mortgage releases or other documentation reflecting the releases contained herein that Maidenform may reasonably request.
