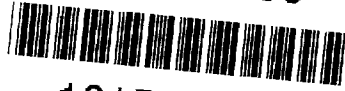

## RELEASE OF SECURITY INTEREST

This RELEASE OF SECURITY INTEREST (the "Release") is made and effective as of the date indicated below and is granted by **FLEET NATIONAL BANK**, f/k/a **BANKBOSTON, N.A.**, successor by merger to **BANKBOSTON, N.A.**, a national banking association (f/k/a **The First National Bank of Boston** and successor by merger to **Rhode Island Hospital Trust National Bank**), individually and in its capacity as agent ("Releasor"), in favor of **COMMEMORATIVE BRANDS, INC.** (f/k/a **Scholastic Brands, Inc.**), a Delaware corporation ("Releasee").

WHEREAS, Releasee and Releasor entered into that certain Revolving Credit, Term Loan and Gold Consignment Agreement dated as of December 16, 1996, as amended or otherwise modified from time to time (the "Agreement");

WHEREAS, pursuant to the Agreement, Releasee executed that certain Restated Trademark Collateral Security And Pledge Agreement dated as of December 16, 1996 ("Security Agreement") and that certain Supplemental Restated Trademark Collateral Security And Pledge Agreement dated as of January 15, 1997 ("Supplemental Security Agreements") in favor of Releasor, pursuant to which Releasee granted to Releasor a continuing security interest in and first priority lien (the "Security Interest") on the Pledged Trademarks (as defined in the Security Agreement) including without limitation the following:

(i) All of the trademarks, service marks, designs, logos, indicia, trade names, corporate names, company names, business names, fictitious business names, trade styles, elements of package or trade dress, and other source and product or service identifiers, used or associated with or appurtenant to the products, services and business of Releasee, that (i) are set forth on Schedule A hereto; or (ii) have been adopted, acquired, owned, held or used by the Releasee or are now owned, held or used by the Releasee, in the Releasee's business, or with the the Releasee's products or services, or in which the Releasee has any right, title and interest, or (iii) are in the future adopted, acquired, owned, held and used by the Releasee in the Releasee's business or with the Releasee's products or services, or in which the Releasee in the future acquires any right, title and interest (defined in the Security Agreement as "Trademarks");

(ii) All past, present or future federal, state, local and foreign registrations of the Trademarks, all past, present and future applications for any such registrations (and any such registrations thereof upon approval of such applications), together with the right (but not the obligation) to apply for such registrations (and prosecute such applications) in the name of Releasee or the Releasor, and to take any and all actions necessary or appropriate to maintain such registrations in effect and renew and extend such registrations (defined in the Security Agreement as "Trademark Registrations");

(iii) Any and all past, present or future rights and interests of the Assignor pursuant to any past, present and future franchising or licensing agreements in favor of the Releasee, or to which the Assignor is a party, pertaining to any Trademarks, Trademark Registrations, or Trademark Rights owned or used by third parties in the past, present or future,

including the right (but not the obligation) in the name of Releasee or the Releasor to enforce, and sue and recover for, any breach or violation of any such Agreement to which Releasee is a party (defined in the Security Agreement as "Trademark License Rights");

(iv) Any and all past, present or future rights in, to and associated with the Trademarks throughout the world, whether arising under federal law, state law, common law, foreign law or otherwise, including the following: all such rights arising out of or associated with the Trademark Registrations; the right (but not the obligation) to register claims under any state, federal or foreign trademark law or regulation; the right (but not the obligation) to sue or bring opposition or cancellation proceedings in the name of the Releasee or the Releasor for any and all past, present and future infringements or dilution of or any other damages or injury to the Trademarks, the Trademark Rights, or the Associated Goodwill, and the rights to damages or profits due or accrued arising out of or in connection with any such past, present or future infringement, dilution, damage or injury, and the Trademark License Rights (defined in the Security Agreement as "Trademark Rights");

(v) All goodwill of the Releasee and its business, products and services appurtenant to, associated with or symbolized by the Trademarks and the use thereof (defined in the Security Agreement as "Associated Goodwill"); and

(vi) All assets, rights and interests of the Releasor that uniquely reflect or embody the Associated Goodwill, including the following: (a) all patents, inventions, copyrights, trade secrets, confidential information, formulae, methods or processes, compounds, recipes, know-how, methods and operating systems, drawings, descriptions, formulations, manufacturing and production and delivery procedures, quality control procedures, product and service specifications, catalogs, price lists, and advertising materials, relating to the manufacture, production, delivery, provision and sale of goods and services under or in association with any of the Trademarks; and (b) the following documents and things in the possession or under the control of the Releasee, or subject to its demand for possession or control, related to the production, delivery, provision and sale by Releasee, or any affiliate, franchisee, licensee or contractor, of products or services sold by or under the authority of the Releasee in connection with the Trademarks or Trademark Rights, whether prior to, on or subsequent to the date hereof: (1) all lists, contracts, ancillary documents and other information that identify, describe or provide information with respect to any customers, dealers or distributors of the Releasee, its affiliates or franchisees or licensees or contractors, for products and services sold under and in connection with the Trademarks or the Trademark Rights, including all lists and documents containing information regarding each customer's, dealer's or distributor's name and address, credit, payment, discount, delivery and other sale terms, and history, pattern and total of purchases by brand, product, style, size and quantity; (2) all agreements (including franchise agreements), product and service specification documents and operating, production and quality control manuals relating to or used in the design, manufacture, production, delivery, provision and sale of products or services under or in connection with the Trademarks or Trademark Rights; (3) all documents and agreements relating to the identity and locations of all sources of supply, all terms of purchase and delivery, for all materials, components, raw materials and other supplies and service used in the manufacture, production, provision, delivery and sale of products



or services under or in connection with the Trademarks or Trademark Rights; and (4) all agreements and documents constituting or concerning the present or future, current or proposed advertising and promotion by the Assignor (or any of its affiliates, franchisees, licensees or contractors) of products or services sold under or in connection with the Trademarks or Trademark Rights (defined in the Security Agreement as "Related Assets");

WHEREAS, the Security Agreement was recorded at the United States Patent and Trademark Office at Reel 1543/Frame 0228-0256 on December 20, 1996 and the Supplemental Security Agreement was recorded at the United States Patent and Trademark Office at Reel 1546/Frame 0108-0119 on January 22, 1997;


WHEREAS, Releasee has requested that Releasor release and discharge fully the Security Interest; and

WHEREAS, Releasor is willing to release and discharge fully the Security Interest.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Releasor, on behalf of itself, its successors, legal representatives and assigns, hereby releases and discharges fully the Security Interest, and all other right, title and interest in and to the Pledged Trademarks conveyed to Releasor (if any) pursuant to the Security Agreement and Supplemental Security Agreement, and Releasor reassigns any and all such right, title and interest that it may have in the Pledged Trademarks (if any) to Releasee. Releasor further agrees to execute and deliver to Releasee any and all further documents or instruments and do any and all further acts which Releasee (or its agents or designees) reasonably requests in order to confirm Releasee's rights in and to the Pledged Trademarks.
