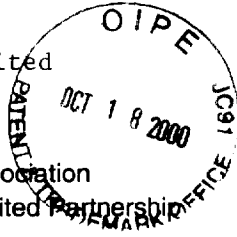

THIS ASSIGNMENT is made 30 day of September 1999

BETWEEN:-

- (1) THOMAS TURTON & SONS LIMITED a company registered in England under number 2910842 whose registered office is at Broombank road, Sheepbridge, Chesterfield S41 9QJ ("the Assignor") and
- (2) PADLEY & VENABLES LIMITED a company registered in England under number 2778086 whose registered office is at Callywhite Lane, Dronfield S18 2XT ("the Assignee").

BACKGROUND

1. The parties entered into an agreement for the sale and purchase of the business and assets of Thomas Turton & Sons Limited pursuant to the terms of an agreement dated 23 September 1999 and made between (1) the Assignor, (2) the Assignee, (3) Stephenson Blake (Holdings) Limited, (4) Julian David Edward Dixon and (5) Charles Lyon Stephenson ("the Agreement").
2. Pursuant to the Agreement the Assignor wishes to assign to the Assignee for the consideration specified below the listed intellectual property detailed in Schedule 1 ("Listed Intellectual Property") and Intellectual Property Rights.

NOW THIS DEED WITNESSETH AS FOLLOWS:-

1. Definitions

Unless defined to the contrary in this Assignment all definitions used in this Assignment shall have the same meaning as set out in the Agreement.

2. Assignment

- 2.1 In consideration of the sum of £1 now paid by the Assignee to the Assignor (the receipt of which the Assignor acknowledges) the Assignor with full title guarantee assigns to the Assignee absolutely together with all the Assignor's rights and interest in respect of the same the Listed Intellectual Property.
- 2.2 In consideration of the sum of £1 now paid by the Assignee to the Assignor (the receipt of which the Assignor acknowledges) the Assignor assigns to the Assignee such right, title and interest as it has to the Intellectual Property Rights.

3. Further Assurance

The Assignor hereby covenants that at the cost and request of the Assignee at any time and from time to time it will execute such deeds or documents and do such acts or things as may be necessary or desirable to give effect to this Assignment.

4. Law and Jurisdiction

This Assignment shall be governed by and construed in all respects in accordance with English law and the parties submit to the non-exclusive jurisdiction of the English Courts.
