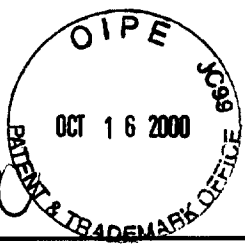

**RELEASE OF INTELLECTUAL PROPERTY**

**THIS RELEASE**, granted on this 31st day of August, 2000, is delivered by **DLJ CAPITAL FUNDING, INC.**, in its capacity as the collateral agent ("**Collateral Agent**") under the Security Agreement referred to below, to **AUTOTOTE SYSTEMS, INC.**, a Delaware corporation ("**Grantor**").

WITNESSETH

**WHEREAS**, Grantor, the other grantors from time to time party thereto and the Collateral Agent have entered into a Security Agreement (the "**Security Agreement**"), dated as of July 28, 1997, pursuant to which Grantor granted to Collateral Agent a security interest in, among other things, (i) the trademarks, together with the registrations and right to all renewals thereof, and the goodwill of the business of Grantor symbolized by the trademarks, trademark applications, trade names and service marks and (ii) patent and copyrights, and all reissues, renewals or extension thereof, copyright registrations and copyright applications (collectively, the "**Intellectual Property**") more particularly set forth on Schedule A hereto, to secure the Obligations (as defined in the Security Agreement) of the Grantor;

**WHEREAS**, the grant of the security interest was evidenced by, among other things, the Security Agreement between the Grantor and the Collateral Agent dated as of July 28, 1997 and filed with the United States Patent and Trademark Office at reel 1621, frame 0485; and


**WHEREAS**, the Collateral Agent wishes to release and restore all right, title and interest in, to and under the Intellectual Property to the Grantor and to dissolve any and all liens and encumbrances respecting the Intellectual Property shown on the attached Schedule A hereto;

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent hereby releases, discharges, quit claims and relinquishes unto the Grantor any and all right, title and interest in, to and under the Intellectual Property, and more particularly the security interest in the (i) trademarks, trademark registrations, trademark applications, trade names and service marks, and (ii) copyrights, copyright registrations and copyright applications set forth on Schedule A hereto granted to the Collateral Agent by the Grantor by the Security Agreement.


