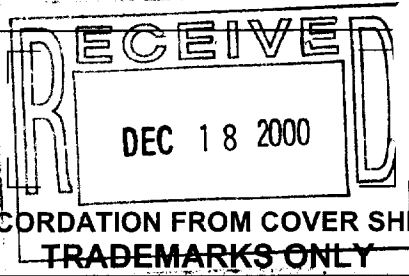

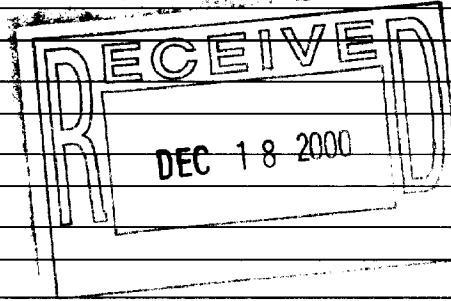

NUNC PRO TUNC ASSIGNMENT

WHEREAS, Ascent Sports, Inc., a corporation organized under the laws of Delaware, located and doing business at 1000 Chopper Circle, Denver, CO 80204 (hereinafter "Assignor") is the owner of the marks listed on Exhibit A hereto, the corresponding federal applications, and the goodwill symbolized thereby (collectively, the "Marks"); and
