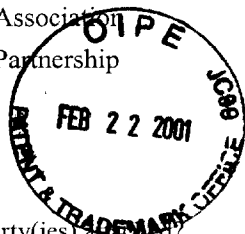

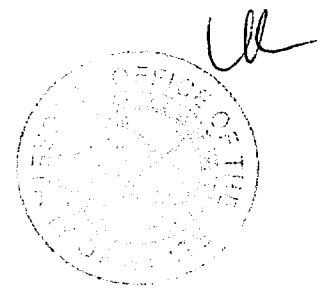

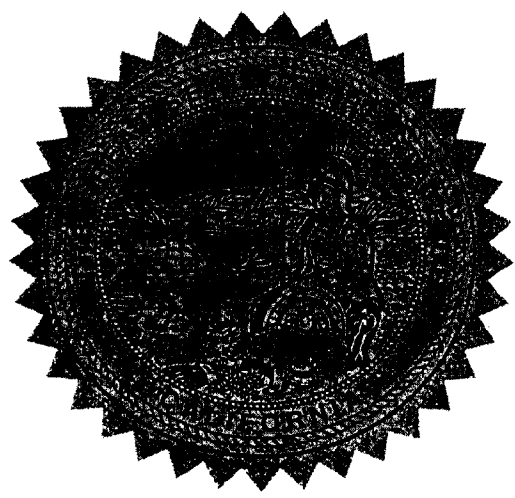

2. Article 1 of the Articles of Incorporation of this corporation is amended to read as follows:


The name of this corporation shall be JWC Manufacturing.
3. The foregoing amendment of Articles of Incorporation has been duly approved by the board of directors.
4. The foregoing amendment of Articles of Incorporation has been duly approved by the required vote of the shareholders in accordance with Section 902, California Corporations Code. The total number of outstanding shares of the corporation is 2,270,525 Class A Common and 65,175 Class B Common. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50%.
