

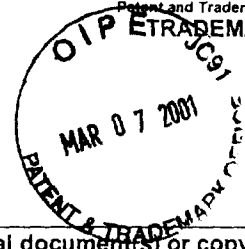

TERMINATION OF SECURITY AGREEMENT  
(TRADEMARKS)

WHEREAS, HOLM ACQUISITION COMPANY, (herein referred to as "Company"), owns trademark registrations in the United States Patent and Trademark Office, more particularly described on Schedule A annexed hereto and made a part hereof (the "Trademarks");

WHEREAS, Company had pledged the Trademarks as security for a Notes Purchase Agreement (the "Security Agreement") with THE PENINSULA FUND II LIMITED PARTNERSHIP, a Delaware limited partnership, MARLBOROUGH CAPITAL INVESTMENT FUND III, L.P., a Delaware limited partnership, and MARLBOROUGH CAPITAL INVESTMENT FUND IIIB, L.P., a Delaware limited partnership (collectively the "Secured Party") and granted to Secured Party a security interest in all right, title and interest of Company in and to the Trademarks (the "Collateral") to secure the prompt payment, performance and observance of certain obligations of Company to Secured Party; and

WHEREAS, Secured Party desires to terminate the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party does hereby terminate the Security Agreement and the security interest in the Collateral evidenced by a Security Agreement dated June 30, 2000, recorded in the United States Patent and Trademark Office on July 19, 2000, at reel 002116, frame 0497.

IN WITNESS WHEREOF, Secured Party has caused this Termination of Security Agreement to be duly executed by its officer thereunto duly authorized as of the 1st day of March, 2001.
