ASSIGNMENT OF MARK

WHEREAS, DiTech Funding has adopted, used, is using and owns the mark "DiTech" (the "Mark") which is registered in the United States Patent and Trademark office, Registration No. 2,158,800 issued on May 19, 1998;

WHEREAS, DiTech Funding, DiTech Escrow Corporation, a California corporation, DiTech Real Estate Corporation, a California corporation (collectively referred to herein as the "Companies"), J. Paul Reddam, the sole shareholder of each of the Companies and GMACM have entered into that certain Asset Purchase Agreement, dated as of March 19, 1999 (the "Purchase Agreement") pursuant to which GMACM will purchase substantially all of the assets and goodwill of the Companies (the "Purchased Assets" (as defined in Purchase Agreement)); and

WHEREAS, the Purchased Assets includes all right, title and interest in and to the Mark together with the goodwill of the business represented by the Mark;

NOW THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged DiTech Funding hereby assigns to GMACM all right, title and interest in and to the Mark, together with the goodwill of the business represented by the Mark and above identified registration thereof.
