## ASSIGNMENT AGREEMENT

This Assignment Agreement is made and entered into effective as of the 31<sup>st</sup> day of December, 2000, between Tops Markets, LLC, a New York limited liability company, with its principal offices at 6363 Main Street, Williamsville, NY 14221 ("Markets") and Tops Brands, Inc., a Delaware corporation, with its only office at 300 Delaware Avenue, Suite 1202, Wilmington, Delaware 19801 ("Brands").

### BACKGROUND

The background of this Assignment Agreement is that Brands is a wholly-owned subsidiary of Markets. Brands has accepted the proposed capital contribution by Markets to transfer to Brands all of its right, title and interest in and to certain intangible property, including but not limited to trademarks, service marks and trade names, whether now owned or existing or hereafter acquired, and as may be more particularly described in Schedule A, attached hereto and made a part hereof, (collectively referred to as the "Property").

### AGREEMENT

NOW, THEREFORE, in consideration of the mutual promises and covenants made herein, the parties hereto, intending to be legally bound, hereby agree as follows:

(A) Markets hereby assigns, transfers and conveys to Brands all right, title and interest in and to the Property, together with the goodwill of the business symbolized thereby.

(B) Brands hereby assumes all liabilities and obligations, and acknowledges existing encumbrances, if applicable, existing or arising in connection with the assignment described in Paragraph (A) hereof, except as otherwise agreed in writing by the parties.

(C) Without limiting the foregoing provisions, Markets agrees to take whatever further action is deemed necessary or appropriate by Brands to properly and completely effect the transfer to Brands of the Property and to establish full custody and ownership of such property by Brands.

(D) This Agreement shall be governed by the laws of the State of Delaware, without reference to its conflict of laws principles.

IN WITNESS WHEREOF the parties hereto, through their respective authorized officers, have executed this Assignment Agreement as of the 31<sup>st</sup> day of December, 2000 and affixed their respective corporate seals hereto.
