

ASSIGNMENT *nunc pro tunc* by and between SPX Development Corporation, a Delaware corporation, located at 700 Terrace Point Drive, Muskegon, Michigan 49443-3301 (“Assignor”) and Toledo Trans-Kit, Inc., an Ohio corporation, located at 1235 Expressway Drive North, Toledo, Ohio 43604 (“Assignee”).

WITNESSETH:

WHEREAS, Assignor is the record owner of the trademark TTK/TOLEDO/TRANS-KIT and the United States Patent and Trademark Office registration therefor, Reg. No. 1,984,971 (“The Mark”);

WHEREAS, on January 30, 2001, the Assignor had assigned all of its rights, title and interest in and to The Mark and the above-identified registration therefor, together with the whole of the good will of the business symbolized by The Mark, to the Assignee, but to date a formal assignment document in a form recordable in the Patent and Trademark Office has not been executed; and
