## **ASSIGNMENT OF TRADEMARK**

This agreement for the Assignment of Trademark Application (the "Agreement"), entered into this 25 day of April , 2001, between Roundhouse Associates, Inc., a Wisconsin corporation ("RAI"), and Roundhouse Marketing & Promotion, Inc., a Wisconsin corporation ("RMPI").

RAI authorizes and requests that the United States Patent and Trademark Office assign said Roundhouse Mark trademark registration to RMPI, the entire right, title, and interest in and to the same, for its sole use and behoof, and for the use and behoof of RMPI's legal representatives, to the full end of the term for which said trademark may be granted, as fully and entirely as the same would have been held by RAI had this Assignment and sale not been made.
