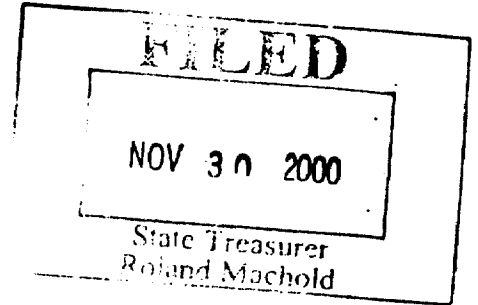
CERTIFICATE OF MERGER

OF

PAPEL GIFTWARE, INC.

AND

PF HOLDINGS, INC.



Pursuant to the provisions of Section 14A:10-7 of the New Jersey Business Corporation Act (the "Act"), it is hereby certified that:

FIRST: The name of the surviving corporation is PF Holdings, Inc.

SECOND: The names and states of incorporation of each of the constituent corporations of the merger are as follows:

NAME	STATE OF INCORPORATION
Papel Giftware, Inc.	New Jersey
PF Holdings, Inc.	Delaware

THIRD: The board of directors of PF Holdings, Inc. approved the plan of merger on November 29, 2000, a copy of which is annexed hereto. No vote of the shareholders of either Papel Giftware, Inc. or the surviving corporation is required because Papel Giftware, Inc. is a wholly owned subsidiary of the surviving corporation.

FOURTH: Papel Giftware, Inc., has 100 shares outstanding, all of which are shares of common stock and all of which are held by PF Holdings, Inc.

FIFTH: The applicable provisions of law of the jurisdiction of organization of PF Holdings, Inc. relating to the merger of Papel Giftware, Inc. with and into PF Holdings, Inc. will have been, upon compliance with any of the filing and recording requirements thereof, complied with.

SIXTH: PF Holdings, Inc. hereby agrees that it may be served with process in the State of New Jersey in any proceeding for the enforcement of any obligation of any domestic corporation or any foreign corporation, previously amenable to suit in the State of New Jersey, which is a party to such merger or consolidation, and in any proceeding for the enforcement of the rights of a dissenting shareholder of any such domestic corporation against the surviving or new corporation.

SEVENTH: PF Holdings, Inc. hereby irrevocably appoints the Secretary of State of the State of New Jersey as its agent to accept service of process in any such proceedings and

designates the following post office address within the state of New Jersey to which said Secretary of State shall mail a copy of the process in such proceeding:


EIGHTH: PF Holdings, Inc. will continue its existence as the surviving corporation under its present name pursuant to the provisions of the laws of its state of incorporation.
