RELEASE OF SECURITY INTEREST OF TRADEMARKS

This Release of Security Interest is dated as of May 22, 2001. Reference is hereby made to the Security Agreement dated as of July 21, 1997 (the "Security Agreement") by and between Playtex Products, Inc. ("Grantor"), a Delaware corporation, and Wells Fargo Bank, N.A., as Collateral Agent ("Collateral Agent"), or an abstract thereof, recorded with the United States Patent and Trademark Office on or about August 12, 1997.


Wells Fargo Bank, N.A. hereby notifies, acknowledges to and agrees with Grantor that the security interest granted by Borrower to Collateral Agent pursuant to the terms of the Grant of Security Interest (as such term as defined in the Security Agreement) including without limitations, the trademarks listed on the attached Schedule A, are terminated and released as of the date hereof, and that Collateral Agent hereby releases and forever discharges all of its right, title and interest of any kind or nature granted, assigned or conveyed pursuant to the Grant of Security Interest to such Trademark Collateral.

Such Collateral Agent releases all liens, pledges, security interests, charges and other encumbrances of whatever nature (collectively, "Encumbrances") on the Release of Security Interest including, without limitation, those Encumbrances created under or in connection with the Security Agreement.

Such Grantor hereby agrees to take such further actions and to execute such further documents as Collateral Agent may reasonably request to effect and evidence this Release, including, without limitation, the execution of any filings, statements, amendments, recordations or other instruments required to maintain the applications or registrations of the Trademark Collateral and record the chain of title accordingly with the United States Patent and Trademark Office.
