

RESTATED CERTIFICATE OF INCORPORATION

RAPID CAST, INC., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware,

DOES HEREBY CERTIFY:

FIRST: That the Board of Directors of said corporation, by the unanimous written consent of its members, filed with the minutes of the Board, duly adopted a resolution proposing and declaring advisable the following amendment to the Restated Certificate of Incorporation of said corporation:

RESOLVED, that the Restated Certificate of Incorporation of RAPID CAST, INC. be amended by changing the First Article thereof so that, as amended, said Article shall be and read as follows:

“FIRST: The name of the corporation is ODC Holdings, Inc. (hereinafter the “Corporation”).”

SECOND: That thereafter, at a meeting of stockholders of said corporation which was duly called and held, upon notice in accordance with Section 222 of the General Corporation Law of the State of Delaware, the necessary number of shares as required by statute were voted in favor of the amendment.

THIRD: That the aforesaid amendment was duly adopted in accordance with the applicable provisions of Section 242 of the General Corporation Law of the State of Delaware.
