TRADEMARK AND PATENT SECURITY AGREEMENT

WHEREAS, Pulaski Furniture Corporation, a Virginia corporation (the "Assignor"), having its chief executive office at One Pulaski Square, Pulaski Virginia 24301, is the owner of all right, title and interest in and to the Security (as defined below);

WHEREAS, the Assignor, the other assignors from time to time party thereto and the Assignee (as defined below), have entered into a Security Agreement, dated as of May 18, 2000 (as amended, modified or supplemented from time to time, the "Security Agreement", the capitalized terms not otherwise defined herein shall be used herein as defined therein);

WHEREAS, BANKERS TRUST COMPANY, as Collateral Agent, for the benefit of the Secured Creditors, having its principal offices at One Bankers Trust Plaza, 130 Liberty Street, New York, New York 10006 (the "Assignee"), desires to acquire a security interest in, and lien upon all of Assignor's right, title and interest in the Security (as defined below);

WHEREAS, the Assignor is willing to assign and grant to the Assignee a security interest in and lien upon the Security (as defined below).

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and subject to the terms and conditions of the Security Agreement, as security for the prompt and complete payment and performance when due of all its Obligations, Assignor does hereby pledge and grant to the Assignee, for the benefit of the Secured Creditors, a continuing first priority security interest in all of the Assignor's right, title and interest in and to, whether now existing or from hereafter from time to time acquired, (i) the Marks including but not limited to those Marks set forth on Schedule A attached hereto, (ii) the Patents (as defined in the Security Agreement) including but not limited to those Patents set forth on Schedule B attached hereto, (iii) all the Proceeds (as such term is defined in the Security Agreement) and products of the Marks and Patents, (iv) the goodwill of the businesses symbolized by the Marks, and (v) all causes of action arising prior to or after the date hereof for infringement or dilution of any of the Marks and Patents (each of (i), (ii), (iii), (iv) and (v) together, the "Security").


Upon the occurrence of the Termination Date, the Assignee shall, upon such satisfaction, execute, acknowledge, and deliver to the Assignor an instrument in writing releasing the security interest in the Security acquired under this Assignment.

This Agreement has been granted in conjunction with the security interest granted to the Assignee under the Security Agreement. The rights and remedies of the Assignee with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Assignment are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.


