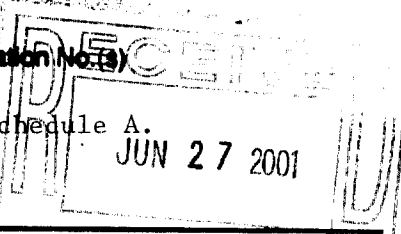

TRADEMARK AND TRADEMARK REGISTRATIONS ASSIGNMENT

This TRADEMARK AND TRADEMARK REGISTRATIONS ASSIGNMENT (the "**Assignment**") is entered into by Harvey Comics, Inc. ("**Assignor**"), as assignor, in favor of HARVEY ENTERTAINMENT, INC., a Delaware corporation with offices located at 435 Hudson, 2nd Floor NY, NY 10014 ("**Assignee**"), as assignee, with reference to the following facts and circumstances:

RECITALS

WHEREAS, pursuant to that certain Asset Purchase and Sale Agreement, dated as of March 7, 2001, as amended by that certain Amendment to Asset Purchase and Sale Agreement effective as of May 4, 2001, and that certain Second Amendment to Asset Purchase and Sale Agreement effective as of June 14, 2001, (as so amended, the "**Asset Purchase Agreement**") by and between Assignor, The Harvey Entertainment Company and BHP Productions, Inc. (collectively with Assignor, the "**Selling Parties**"), on the one hand, and Assignee, as assignee of Classic Media, LLC, on the other hand, the Selling Parties have agreed to sell and Assignee has agreed to purchase all right, title and interest in and to the assets, properties and rights owned or held by Sellers and used in the conduct of the Harvey Entertainment Business, but excluding the Retained Assets (collectively, the "**Harvey Entertainment Assets**"), which include but are not limited to the trademarks set forth on Schedule A attached hereto and incorporated herein by this reference (the "**Marks**");

WHEREAS, Assignor is the owner of the entire right, title and interest in and to the Marks;

WHEREAS, pursuant to the Asset Purchase Agreement, Assignee is acquiring all of Assignor's rights under trademark relating to the Harvey Entertainment Assets, including, but not limited to, all right, title and interest in and to the Marks, all Federal, state, and foreign applications and/or registrations of or related to the Marks heretofore granted or applied for, including without limitation all renewals and extensions thereof, the right to file applications for Federal, state and foreign registrations, renewals and extensions of or related to the Marks, all of Assignor's assets, receivables, properties, rights, contracts and obligations related to the Marks, all actions, claims and causes of action related to the Marks, the right to bring and maintain legal actions related to the Marks and to sue for past and future infringement of the Marks, any and all damages, profits, penalties and other recoveries related to the foregoing, and any and all common law rights of Assignor to the Marks in the United States, any state thereof, and in foreign countries, in each case, to the extent and subject to the limitations set forth in the Asset Purchase Agreement (collectively, the "**Mark Rights**").

AGREEMENT

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby irrevocably assign and transfer unto Assignee all of its right, title and interest in and to the Marks and the Mark Rights, together with the goodwill of the business symbolized by such Marks and Mark

Rights, in each case, to the extent and subject to the limitations set forth in the Asset Purchase Agreement.

This Assignment is given pursuant to the terms, conditions and requirements of the Asset Purchase Agreement, and is intended to convey fully the rights and interests required thereby to be conveyed with respect to the Marks and Mark Rights being assigned to Assignee hereunder. **THE MARKS AND MARK RIGHTS THAT ARE BEING ASSIGNED AND TRANSFERRED TO ASSIGNEE HEREUNDER ARE BEING ASSIGNED AND TRANSFERRED SUBJECT TO THE REPRESENTATIONS AND WARRANTIES OF ASSIGNOR CONTAINED IN THE ASSET PURCHASE AGREEMENT. IN THE EVENT OF A CONFLICT OR AMBIGUITY BETWEEN THE PROVISIONS OF THIS ASSIGNMENT AND THE ASSET PURCHASE AGREEMENT, THE PROVISIONS OF THE ASSET PURCHASE AGREEMENT SHALL CONTROL.**



Without limiting the foregoing paragraph, effective at the Closing, Assignor hereby irrevocably appoint Assignee and its officers, employees and agents, and each of them, as such Assignor's true and lawful attorneys-in-fact, with full power of substitution to do all things and to take such actions in the name and on behalf of Assignor that Assignee may deem necessary or advisable to vest in Assignee all right, title and interest of Assignor in and to the Marks and the Mark Rights and otherwise to carry out the purpose and intent of this Assignment, including, without limitation, to sign and deliver any certificates of ownership, formalization documents and other documentation necessary to transfer title to any Marks and/or Mark Rights to Assignee and to cooperate in procedures to be taken with the United States Patent and Trademark Office and elsewhere singly by Assignee to record the transfer of the Marks to Assignee. This appointment and power-of-attorney is irrevocable, is coupled with an interest and is granted in consideration of Assignor's entering into this Assignment.
