INTELLECTUAL PROPERTY ASSIGNMENT

2. Assignment of Moral Rights

To the fullest extent allowable under any applicable law and subject to the terms and conditions of the Agreement between Assignor, Assignee, Ronald David Associates, LLC and David Kurtz, Assignor hereby irrevocably waives or assigns to Assignee any and all right of "droit moral" or "moral rights" or similar rights which Assignor may now have in the copyrighted or copyrightable materials including advertising and marketing materials, manuals and instructions booklets and flyers, web pages, paper and on-line catalog ("Work") and any other works now containing the Work.


3. Assignment of Patents
