## TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT dated as of June 22, 2001 by Novartis Pharmaceuticals Corporation, a Delaware corporation, and Novartis Corporation, a New York corporation (each, an "Assignor" and, collectively, "Assignors"), to Sherwood Services AG, a stock corporation organized under the laws of Switzerland ("Assignee").

### BACKGROUND

2. Each Assignor hereby authorizes the Assistant Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office to record the transfer of the registrations for the Product Trademarks, identified in Schedule A, to Assignee as assignee of the appropriate Assignor's entire right, title and interest therein or otherwise as Assignee may direct, in accordance with this Trademark Assignment.

3. This Trademark Assignment may be executed in one or more counterparts, all of which shall be considered one and the same assignment and shall become effective when one or more counterparts have been signed by each of the parties and delivered to the other parties, it being understood that all parties need not sign the same counterpart.

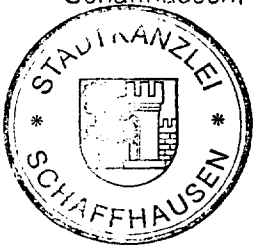
