AMENDMENT NO. 1 TO TRADEMARK SECURITY AGREEMENT

This AMENDMENT NO. 1 TO TRADEMARK SECURITY AGREEMENT (this "Amendment"), dated as of April 27, 2001, between TONE BROTHERS, INC. ("TBI") and THE CHASE MANHATTAN BANK (the "Security Trustee"), as cotrustee under a certain Security Trust Deed dated as of July 28, 1998 (the "Security Trust"), modifies that certain Trademark Security Agreement, dated as of July 28, 1998 (the "Existing Trademark Security Agreement") between TBI and the Security Trustee.

WHEREAS, pursuant to the Existing Trademark Security Agreement, TBI granted to the Security Trustee a continuing security interest in and first priority lien on all the Trademarks (as defined in the Existing Trademark Security Agreement), and pledged, mortgaged and hypothecated (but did not transfer title to) the Trademarks to the Security Trustee; and

WHEREAS, Burns Philp Food Inc. has transferred to TBI its right, title and interest in the trademarks listed on <u>Exhibit A</u> hereto (the "Additional Trademarks"); and

WHEREAS, in connection therewith, TBI desires to amend the Existing Trademark Security Agreement by granting the Security Trustee a continuing security interest in and first priority lien on all the Additional Trademarks, and by pledging, mortgaging and hypothecating (but not transferring title to) the Additional Trademarks to the Security Trustee, and TBI and the Security Trustee desire to permit such amendment.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. DEFINED TERMS.

Capitalized terms used and not defined herein shall have the same meanings given to them in the Existing Trademark Security Agreement.

2. AMENDMENTS TO EXISTING TRADEMARK SECURITY AGREEMENT.

Schedule A of the Existing Trademark Security Agreement is hereby amended to include the Additional Trademarks listed on <u>Exhibit A</u> attached hereto.

3. NO OTHER MODIFICATIONS; CONFIRMATION.

All the provisions of the Existing Trademark Security Agreement, are and shall remain in full force and effect. All references to the Existing Trademark Security Agreement in any agreements, instruments or documents evidencing or securing payment or performance under the Security Trust shall be references to the Existing Trademark Security Agreement, as modified by this Amendment and as hereafter amended, modified or supplemented in accordance with its terms, and all references to Trademarks also shall include all of the Additional Trademarks described on Exhibit A attached hereto.

4.4 Execution in Counterpart.

This Amendment may be executed in one or more counterparts and shall be effective when at least one counterpart shall have been executed by each party hereto, and each set of counterparts that, collectively, show execution by each party hereto shall constitute one duplicate original.
