COLLATERAL ASSIGNMENT OF TRADEMARKS

NOW, THEREFORE, in consideration of any loan, advance, extension of credit and/or other financial accommodation at any time made by Assignee to or for the benefit of Assignor, and of the promises set forth in the Loan Agreement, and for other good and valuable consideration, the receipt of which is hereby acknowledged, the parties hereto agree as follows:

- 1. Assignor does hereby assign to Assignee all rights, title and interest in and to the Trademarks, the goodwill of the business symbolized by the Trademarks, along with the registrations and applications thereof, the numbers of which are contained herein.
- 2. This Assignment is made as collateral security for any and all Borrower's Liabilities (as defined under the Loan Agreement") to Assignee, either now existing or that may hereafter arise between Assignor and Assignee.
- 3. This Assignment is made upon the express condition that if Assignee shall pay or cause to be paid to Assignee, its executors, administrators, personal representatives or assigns, all of Borrower's Liabilities as defined under the Loan Agreement as the same shall become due, then this Assignment shall be void and of no effect.
- 4. Assignee covenants that Assignee will not exercise either the right to use or license the Trademarks or to collect any royalty fees thereof until there has been default in any of the then existing Borrower's Liabilities as defined and secured by the Loan Agreement and secured by this Assignment.


