

## RELEASE AND REASSIGNMENT OF TRADEMARK

WHEREAS, The William Carter Company, a Massachusetts corporation (the "Company"), owns the registered trademarks described in the attached Schedule A (the "Marks"), for which recordings are filed in the United States Patent and Trademark Office under the number set forth in the attached Schedule A; and

WHEREAS, pursuant to that certain Amended and Restated Pledgor Security Agreement dated as of March 30, 1990 (the "First Amendment") and that certain Second Amended and Restated Pledgor Security Agreement dated as of December 5, 1991 (the "Second Amendment"), the Company granted a security interest in the Marks to The Bank of New York, as Collateral Agent (the "Agent") for a group of lenders, to secure performance by the Company of its obligations to such lenders;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent hereby terminates or reassigns and reconveys to the Company, as applicable, all right, title and interest granted or assigned to it under the First Amendment and Second Amendment in, to and under the Marks and all the good will of the business symbolized by the Marks, together with the application, registration and recordings in the United States Patent and Trademark Office with respect thereto, and all reissues, extensions or renewals thereof, together with the right to sue and recover damages for future infringements thereof and to stand in the place of the Agent in all matters related thereto. Any assignment or conveyance made hereby by the Agent is made without representation or warranty of any kind, whether express or implied.
