## SECURITY AGREEMENT

### TRADEMARKS

WHEREAS, REMINGTON CORPORATION, L.L.C., a Delaware limited liability company (herein referred to as "Grantor"), whose address is 60 Main Street, Bridgeport, Connecticut 06604, (1) has adopted, used and is using, or (2) has intended to use and filed an application indicating that intention, but has not yet filed an allegation of use under Section 1(c) or 1(d) of the Trademark Act, or (3) has filed an application based on an intention to use and has since used and has filed an allegation of use under Section 1(c) or 1(d) of the Trademark Act, the trademarks, trade names, trade styles and service marks listed on the attached Schedule 2-A, which trademarks, trade names, trade styles and service marks are registered in or have been applied for registration in the United States Patent and Trademark Office (the "Trademarks");

WHEREAS, REMINGTON PRODUCTS COMPANY, L.L.C., a Delaware limited liability company (the "Company"), and certain of its subsidiaries, have entered into a Credit and Guarantee Agreement dated as of August 21, 2001 (said Agreement as it may be hereafter amended, supplemented, restated or otherwise modified from time to time being the "Credit Agreement") with the Lenders party thereto, Fleet Securities, Inc., as sole advisor, lead arranger and book manager, Congress Financial Corporation (New England), as syndication agent and co-arranger, and Fleet Capital Corporation, as administrative agent (together with any successor in such capacity, is herein referred to as the "Grantee"), and in connection therewith, the Secured Parties (as defined in the Security Agreement and Mortgage (defined below)) are desirous of having a security interest and mortgage in favor of Grantee on the Trademarks in order to secure the payment of certain obligations of the Company and its Subsidiaries now or hereafter owing to the Secured Parties;

WHEREAS, Grantor, a direct subsidiary of the Company, together with certain of its affiliates, has entered into a Patents, Trademarks and Copyrights Security Agreement and Mortgage dated as of August 21, 2001 (said Agreement, as it may hereafter be amended, supplemented or otherwise modified from time to time being the "Security Agreement and Mortgage"; capitalized terms used therein and not otherwise defined herein being used herein as therein defined) in favor of the Grantee; and

WHEREAS, pursuant to the Security Agreement and Mortgage, Grantor has granted to Grantee a security interest in, and mortgage on, all right, title and interest of Grantor in and to the Trademarks, designs and general intangibles of like nature, now existing or hereafter adopted or acquired, and the goodwill of the business symbolized by the Trademarks and the applications, registrations and recordings thereof in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State thereof, or any political subdivision thereof, all whether now or hereafter owned by Grantor, and all reissues, extensions or renewals thereof and all proceeds thereof, including, without limitation, any claims by

Assignor against third parties for infringement thereof (the "Collateral"), to secure the payment, performance and observance of the Secured Obligations;


