## RELEASE OF SECURITY INTEREST

This is a release of Security Interest dated September 29, 1999, made by The Bank of Nova Scotia, as administrative agent (together with any successor(s) thereto in such capacity for each of the Secured Parties noted in the preamble of the Trademark Security Agreement), with its business address at One Liberty Plaza, New York, New York 10006 ("the Lenders") to Weight Watchers International, Inc., a Virginia corporation, with its business address at 175 Crossways Park West, Woodbury, New York 11797, and each of its U.S. subsidiaries, namely, Waist Watchers, Inc., Weight Watchers Direct, Inc., Weight Watchers North America, Inc., W/W Twentyfirst Corporation, W.W. Weight Reduction Services, Inc., W.W.I. European Services, Ltd., W.W. Inventory Service Corp., 58 WW Food Corp., Weight Watchers Camps, Inc., and W.W. Camps and Spas, Inc., ("Borrowers").

WHEREAS, Borrower and Lendor entered into a Trademark Security Interest dated September 29, 1999, which was secured by, inter alia, the granting by Borrowers to Lenders of a security interest in the Trademark Collateral noted in Attachment 1; and


