### ASSIGNMENT AND RELEASE OF SECURITY INTEREST

WHEREAS, Citizens Bank of Massachusetts, a Massachusetts bank, f/k/a UTrust ("Citizens"), and New Vision Microelectronic Manufacturing Systems, Inc., a Delaware corporation ("New Vision") executed a Trademark Collateral Assignment and Security Agreement (the "Agreement"), dated October 23, 1998;
