NUNC PRO TUNC ASSIGNMENT OF TRADEMARK (RESCISSION)

WHEREAS, CARL VON HIRSCH, an individual, in the county of San Diego, State of California (Assignor) on or about May 9, 2000, assigned by Nunc Pro Tunc Assignment, having an effective date of August 18, 1998, U.S. Trademark Registration No. 1,179,031, registered in the U.S. Patent and Trademark Office on November 24, 1981, for the mark QUICKSILVER to Quicksilver Enterprises, Inc.; and

WHEREAS, QUICKSILVER ENTERPRISES, INC., was improperly identified as a California corporation, and that there was no entity by such name as Assignor intended to assign the subject trademark to an entity with a similar, but different name;

WHEREAS, it is in the interest of Carl von Hirsch and said non-existent Quicksilver Enterprises, Inc. to rescind such May 9, 2000 Nunc Pro Tunc Assignment.

NOW, THEREFORE, in consideration of \$1.00 and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Carl von Hirsch, and said non-existent Quicksilver Enterprises, Inc. has, had and does hereby rescind that certain Nunc Pro Tunc Assignment, executed May 9, 2000, having an effective date of August 18, 1998, and re-establish and confirm that U.S. Trademark Registration No. 1,179,031, registered in the U.S. Trademark Office on November 24, 1981, for the mark QUICKSILVER as of August 18, 1998, is owned, including all rights, title and interest in, to and under such trademark registration, including the goodwill of the business in connection therewith by Carl von Hirsch as of such effective date of August 18, 1998.
