ASSIGNMENT

WHEREAS KORD PRODUCTS LIMITED, 1186320 ONTARIO INC., 1219754 ONTARIO INC. and CAMVEC CORPORATION, amongst other parties have heretofore entered into an agreement dated November 13, 1999 ("the Asset Purchase Agreement") whereby KORD PRODUCTS LIMITED agreed to sell substantially all of its assets, business and undertaking to 1219754 ONTARIO INC. upon the terms therein set forth;

AND WHEREAS KORD PRODUCTS LIMITED, 1186320 ONTARIO INC. and CAMVEC CORPORATION amalgamated effective November 30, 1999 pursuant to the provisions of The Business Corporations Act (Ontario) to form the amalgamated entity, CAMVEC CORPORATION;

AND WHEREAS CAMVEC CORPORATION by virtue of the provisions of The Business Corporations Act (Ontario) possesses all the property, rights, privileges and franchises of each of the amalgamating corporations;

AND WHEREAS by Articles of Amendment effective November 25, 1999, 1219754 ONTARIO INC. changed its name to KORD PRODUCTS INC.;

AND WHEREAS CAMVEC CORPORATION has executed and delivered the within instrument in pursuance of the obligations of CAMVEC CORPORATION and of KORD PRODUCT LIMITED contained in the Asset Purchase Agreement;

AND WHEREAS the term "Purchased Business" when used herein shall have the meaning ascribed thereto in the Asset Purchase Agreement.
