ASSIGNMENT OF UNITED STATES TRADEMARKS

WHEREAS, Assignors are the sole and exclusive owners of the entire right, title and interest in, to and under certain United States trademarks, and United States registrations therefor as identified in Schedule I hereto, and United States applications to register therefor as identified in Schedule II hereto, (collectively, the "U.S. Trademarks");

WHEREAS, Owens Corning wishes to acquire and cause Assignor to assign to Owens-Corning Fiberglas Technology Inc. (its Affiliate) ("Assignee"), and Assignors wish to assign to Assignee, all worldwide right, title and interest in, to and under the U.S. Trademarks, as more fully set forth below;

NOW THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignors do hereby sell, assign, transfer and set over to Assignee, the entire worldwide right, title and interest in, to and under the U.S. Trademarks, together with all similar variations thereof and all goodwill associated with the products heretofore sold and business heretofore conducted thereunder, for its own use and enjoyment, and the use and enjoyment of its successors, assigns and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignors if this Assignment had not been made; together with all income, royalties, damages or payments due or payable on the Effective Date or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the U.S. Trademarks, with the right to sue for and collect the same for its own use and enjoyment, and
