**TRADEMARK ASSIGNMENT AGREEMENT**

WHEREAS, Chinin USA, Inc., an Illinois corporation located at 1010 Jorie Boulevard, Oak Brook, IL 60521 (hereinafter referred to as "Chinin") is currently listed in the U.S. Patent and Trademark Office as the registrant of the trademark PRO EDGE, Reg. No. 2,019,394 (the "Trademark");

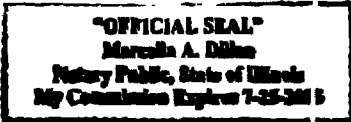
