NUNC PRO TUNC ASSIGNMENT

WHEREAS, TyCom (US) Inc., a corporation organized under the laws of the State of Delaware, located and doing business at 10 Park Avenue, Morristown, NJ 07960 (hereinafter "Assignor") is the owner of the trademarks listed on the attached Appendix A (the "Trademarks"), their respective U.S. trademark applications and the goodwill symbolized thereby; and


