3. Consideration

3.1 In consideration for the assignment in clause 2.1, the Assignee pays to the Assignor the sum of £1 (+ VAT, if applicable), receipt of which is acknowledged by the Assignor.

4.1 This Agreement shall be governed by and construed in accordance with English law.
