TRADEMARK SECURITY AGREEMENT

**TRADEMARK SECURITY AGREEMENT**, dated as of January 25, 2002, by Hexcel Corporation (the "Company") and each of the other entities listed on the signature pages hereof (each a "Grantor" and, collectively, the "Grantors"), in favor of Citibank, N.A., as Documentation Agent (the "Documentation Agent") for the Lenders (as defined in the Credit Agreement referred to below).

**WITNESSETH:**

WHEREAS, pursuant to the Second Amended and Restated Credit Agreement, dated as of September 15, 1998 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), among the Company, the Foreign Borrowers from time to time party thereto (together with the Company, the "Borrowers") the Lenders, Credit Suisse First Boston, as Administrative Agent (the "Administrative Agent") and Lead Arranger, and the Documentation Agent, the Lenders have severally agreed to make extensions of credit to the Borrower upon the terms and subject to the conditions set forth therein; and

WHEREAS, all the Grantors are party to an Amended and Restated Collateral Agreement, dated as of March 7, 2001 (as amended, supplemented or otherwise modified from time to time, the "Collateral Agreement") in favor of the Documentation Agent for the Lenders, pursuant to which the Grantors are required to execute and deliver this Trademark Security Agreement;

NOW, THEREFORE, in consideration of the premises and to induce the Documentation Agent to enter into the Collateral Agreement and to induce the Lenders to make their respective extensions of credit to the Borrowers under the Credit Agreement, each Grantor hereby agrees with the Documentation Agent as follows:

**SECTION 1. Defined Terms.** Unless otherwise defined herein, terms defined in the Credit Agreement or in the Collateral Agreement and used herein have the meaning given to them in the Credit Agreement or the Collateral Agreement.

**SECTION 2. Grant of Security Interest in Trademark Collateral.** Each Grantor hereby assigns and transfers to the Documentation Agent, and hereby grants to the Documentation Agent, for the ratable benefit of the Administrative Agent, the Documentation Agent and the Lenders (and their affiliates and subsidiaries which hold Obligations), a security interest in, all of the following property now owned or at any time hereafter acquired by such Grantor or in which such Grantor now has or at any time in the future may acquire any right, title or interest (collectively, the "Trademark Collateral"), as collateral security for the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of such Grantor's Obligations:

(a) all of its Trademarks and Trademark Licenses to which it is a party, including those referred to on *Schedule I* hereto; and

(b) to the extent not otherwise included, all Proceeds and products of any and all of the foregoing.

**SECTION 3. Security Agreement.** The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Documentation Agent pursuant to the Collateral Agreement and each Grantor hereby acknowledges and affirms that the rights and remedies of the Documentation Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Collateral Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.


