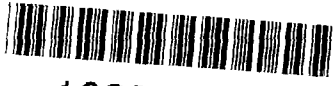



ASSIGNMENT

WHEREAS, FLORIDA BOTTLING COMPANY, f/k/a Russell's Fruit Juice Company, Inc., a corporation duly organized under the laws of the State of Florida, and having its principal place of business at 1035 N.W. 21 Terrace, County of Miami-Dade, and State of Florida, is the owner of United States Trademark Registration No. 1,187,977 issued January 26, 1982, and covering the mark "Lakewood;" and

WHEREAS, The Fuhrman Children's Irrevocable Trust created by agreement dated June 30, 1994, between Thomas R. Fuhrman and Michael P. Maguire of the County of Miami-Dade, and State of Florida, ("the Trust") is desirous of acquiring said Trademark Registration for the Childrens' GST Trusts.
