## TRADEMARK SECURITY AGREEMENT

**THIS TRADEMARK SECURITY AGREEMENT** (this "Agreement") is made as of May 1, 2002, between **NLP IP COMPANY**, a Delaware corporation, having offices at 345 Park Avenue South, New York, New York 10010 ("**Grantor**"), and **GENERAL ELECTRIC CAPITAL CORPORATION**, a Delaware corporation, having offices at 2325 Lakeview, Suite 700, Alpharetta, Georgia 30004-1976, as agent ("**Agent**") for itself and the Lenders under the Credit Agreement (each as defined below).

### W I T N E S S E T H:

**WHEREAS**, in order to induce Agent and Lenders to make the Loans and incur Letter of Credit Obligations as provided for that certain Credit Agreement dated as of the date hereof, by and among The New York Law Publishing Company, American Lawyer Media Holdings, Inc., American Lawyer Media, Inc., the Lenders and Agent (as the same may hereafter be amended, restated, supplemented or replaced from time to time, the "**Credit Agreement**"), Grantor has agreed to grant a continuing security interest on its trademark rights and related assets of Grantor in accordance with the terms of this Agreement to secure the Obligations.

**NOW, THEREFORE**, in consideration of the foregoing premises and other good and valuable consideration, Grantor hereby agrees that all capitalized terms used herein (and not otherwise expressly defined herein) shall have the meanings given such terms in the Credit Agreement, and Grantor and Agent hereby further agree as follows:

1. **Grant of Lien.** To secure the prompt and complete payment, performance and observance of all of the Obligations, each Grantor hereby grants, assigns, conveys, mortgages, pledges, hypothecates and transfers to Agent, for itself and the benefit of Lenders, a Lien upon all of its right, title and interest in, to and under all personal property and other assets, whether now owned by or owing to, or hereafter acquired by or arising in favor of such Grantor, and whether owned or consigned by or to, or leased from or to, such Grantor, and regardless of where located (all of which being hereinafter collectively referred to as the "**Trademark Collateral**"), including without limitation:

- (i) all Trademarks, including further without limitation those set forth on Schedule I hereto; and
- (ii) to the extent not otherwise included, all Proceeds, tort claims, insurance claims and other rights to payments not otherwise included in the foregoing and products of the foregoing and all accessions to, substitutions and replacements for, and rents and profits of, each of the foregoing.

2. **Security Agreement**. The security interest granted by Grantor pursuant to this Agreement is granted in conjunction with the security interest granted by Grantor to Agent, on behalf of itself and the Lenders, pursuant to the Security Agreement. Grantor hereby acknowledges and affirms that the rights and remedies of Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. Grantor and Agent expressly agree that the security interests granted by Grantor in the Trademark Collateral under this Trademark Agreement and the Security Agreement are intended to be treated as a single security interest for purposes of Article 9 of the Code and other applicable law and the exercise by the Agent or the Lenders of any rights or remedies with respect to any of the Trademark Collateral shall be deemed to be an exercise of such rights or remedies in connection with both this Agreement and the Security Agreement. In the event of any inconsistency between the terms and conditions of this Agreement and those of the Security Agreement, then the terms and conditions of the Security Agreement shall prevail.

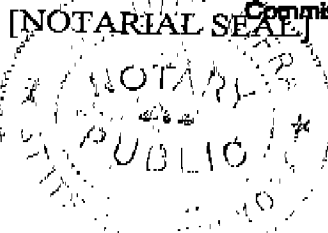
