TERMINATION OF TRADEMARK MORTGAGE AND SECURITY AGREEMENT

This Termination of Patent and Trademark Security Agreement (this "Termination"), dated as of March 18, 2002 is executed by Societe Generale, as Agent (the "Agent"), having its principal offices at 1221 Avenue of the Americas, New York, NY 10020, in favor of Hollywood Entertainment Corporation, an Oregon corporation (the "Debtor"), having its principal offices at 25600 S.W. Parkway Center Drive, Wilsonville, OR 97070.

RECITALS

WHEREAS, Debtor, various lenders, and Agent entered into a certain Revolving Credit Agreement, dated as of September 5, 1997 (as amended, the "Credit Agreement"); and

WHEREAS, in connection with the Revolving Credit Agreement, Debtor and Agent entered into a certain Trademark Mortgage and Security Agreement dated as of September 11, 1997 (as amended, the "Trademark Mortgage Security Agreement"); and

WHEREAS, pursuant to the Trademark Mortgage Security Agreement, Debtor granted to Agent a security interest in certain "Collateral" including certain trademarks; and

WHEREAS, the Revolving Credit Agreement and Trademark Mortgage Security Agreement have been terminated.

NOW, THEREFORE, Agent agrees as follows:

1. Agent is executing and delivering this Termination as further evidence of the termination of the Trademark Mortgage Security Agreement.
2. Agent claims no right, title or interest whatsoever in or to any of the "Collateral" described in the Trademark Mortgage Security Agreement, and, accordingly, Agent expressly terminates its security interest in the registered trademarks listed on Exhibit A hereto, which security interest was evidenced by the recordation of the Trademark Mortgage Security Agreement with the United States Patent and Trademark Office on July 9, 1999 as to trademarks, in Reel/Frame 1941/0367.
