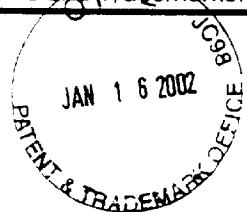

AND WHEREAS, AT Plastics Inc. has satisfied the debentures and other debts presented in the above-identified Indentures;




