AGREEMENT TO SELL AND ASSIGN TRADEMARKS

WHEREAS, Fruit desires to acquire the entire right, title and interest in and to the Trademarks and the registrations thereof, together with the good will of the business symbolized by the Trademarks.

NOW THEREOFRE, for good and valuable consideration, the receipt of which is hereby acknowledged, the parties agree as follows:

1. Camp does hereby sell, assign and transfer to Fruit of the Loom, Inc., a New York corporation, its successors and assigns all rights, title and interest in and to the Trademarks together with the good will of the business symbolized thereby.
2. All cost associated with the recordation of the said assignment from Camp to Fruit shall be borne by Fruit.
