RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST (this "Release") is dated as of the day of June, 2002, from WACHOVIA BANK, NATIONAL ASSOCIATION, successor to FIRST UNION NATIONAL BANK (the "Bank"), for the benefit of TREX COMPANY, LLC, a Delaware limited liability company ("TREX LLC"), and TREX COMPANY, INC., a Delaware corporation ("Trex Inc." and, together with TREX LLC, the "Debtors").

WHEREAS, the Bank and the Debtors are parties to a certain Security Agreement dated as of September 30, 2001 (the "Security Agreement"), pursuant to which the Debtors granted to the Bank a security interest in certain Collateral (as defined in the Security Agreement) as security for certain obligations of the Debtors to the Bank (the "Secured Obligations"); and

WHEREAS, the Secured Obligations have been paid and performed in full by the Debtors and the Debtors have requested that the Bank execute this Release to effect the release of its security interest in the Collateral.

(the "Escrow Agent") and such other persons as the Debtors or the Escrow Agent may direct, to file any and all UCC termination statements, UCC partial release statements and/or UCC amendments necessary to release all UCC financing statements of record describing the Collateral or any part thereof and naming either Debtor as debtor and the Bank as secured party, including without limitation the UCC financing statements described on Exhibit B attached hereto and made a part hereof. The Debtors, the Escrow Agent and such other persons as the Debtors or the Escrow Agent may direct are further authorized to file this Release (along with any appropriate cover sheet) with the United States Patent and Trademark Office to evidence the release of the Bank's security interest in the IP Collateral.

The Bank acknowledges and agrees that each of Branch Banking and Trust Company of Virginia, both individually and in its capacity as collateral agent for itself, Teachers Insurance and Annuity Association of America, Nationwide Life Insurance Company, Nationwide Life and Annuity Insurance Company, Nationwide Mutual Insurance Company, AMCO Insurance Company and Great-West Life & Annuity Insurance Company, shall be an express beneficiary of this Release.
