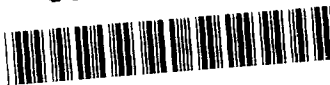

**I.**

The name of the Corporation is **SHAW INDUSTRIES, INC.** (the "Corporation").

The Corporation hereby amends the Corporation's Amended and Restated Articles of Incorporation, as amended, by deleting in its entirety Section 1 titled "Name" and inserting in lieu thereof the following new Section 1:

1. **Name.** The name of the Corporation is **Shaw Industries Group, Inc.**

**III**

All other provisions of the Corporation's Amended and Restated Articles of Incorporation, as heretofore amended, shall remain in full force and effect.

**IV.**

The amendment set forth herein was approved by the unanimous written consent of the Sole Director of the Corporation on the 20 day of June, 2002 in accordance with Section 14-2-1002 of the Georgia Business Corporation Code.

**V.**

In accordance with Section 14-2-1002 of the Georgia Business Corporation Code, shareholder approval of the amendment was not required.


**VI**
