FIRST AMENDMENT TO
TRADEMARK SECURITY AGREEMENT

THIS FIRST AMENDMENT TO TRADEMARK SECURITY AGREEMENT (this "Amendment"), dated as of June 21, 2002, is entered into by each of the Persons listed on the signature page (each, a "Grantor" and collectively, the "Grantors"), jointly and severally, in favor of Bank of America, N.A., as administrative agent (the "Administrative Agent"), with reference to the following facts:

RECITALS

A. The Grantors (other than the New Subsidiaries) and the Administrative Agent are parties to the Trademark Security Agreement, dated as of October 12, 2001 (the "Trademark Security Agreement"), pursuant to which such Grantors granted the Administrative Agent a security interest in all of their Trademarks and related Collateral as security for their respective Secured Obligations to the Lenders.

B. Each of Toymax International, Inc., Toymax, Inc., Webgadgits, Inc., Funnoodle, Inc., Go Fly A Kite, Inc., Monogram International, Inc., Maxverse Interactive, Inc. and Toymax Sales, Inc. (collectively, the "New Subsidiaries") has become a subsidiary of JAKKS Pacific, Inc. and has executed a Joinder Instrument to Trademark Securities Agreement, of even date herewith, by which such New Subsidiary has become an additional Grantor under the Trademark Security Agreement.

C. The Grantors and the Administrative Agent wish to amend the Trademark Security Agreement to add the Trademarks of each of the New Subsidiaries to Schedule 1 to the Trademark Security Agreement in order to make such Trademarks part of the Collateral under the Trademark Security Agreement.


NOW, THEREFORE, the parties hereby agree as follows:

1. Defined Terms. Any and all initially capitalized terms used in this Amendment (including, without limitation, in the recitals hereto) without definition shall have the respective meanings specified in the Trademark Security Agreement.
2. Addition of New Subsidiary Trademarks. Schedule 1 to the Trademark Security Agreement is hereby amended and supplemented by including the Trademarks of each of the New Subsidiaries identified in Schedule 1 to this Amendment as part of the Collateral:
3. No Other Amendments. Except as expressly amended hereby, the Trademark Security Agreement shall remain unaltered and in full force and effect.
