

## ASSIGNMENT OF BLOUNT TRADEMARKS

This Assignment of Blount Trademarks (the "Assignment of Blount Trademarks"), made and entered into as of the 4th day of December, 2001, is by and between Blount, Inc., a Delaware corporation, having its principal place of business at 4520 Executive Park Drive, Montgomery, Alabama 36116-1602 ("Assignor"), and Ammunition Accessories, Inc., a corporation organized and existing under the laws of the State of Delaware, having its principal place of business at 4520 Executive Park Drive, Montgomery, Alabama 36116-1602 ("Assignee").

WHEREAS, Assignor has adopted and used the marks identified in the attached Schedule I (the "Marks");

WHEREAS, Assignee desires to acquire the Marks and enjoy the protection of the registrations of the Marks;

WHEREAS, Assignor, Blount International, Inc. and Alliant Techsystems Inc., a Delaware corporation having its principal place of business at 5050 Lincoln Drive, Edina, Minnesota 55436 ("ATK") have entered into a Stock Purchase Agreement (the "Stock Purchase Agreement") dated as of November 6, 2001, as amended, pursuant to which ATK will acquire all shares of capital stock of Assignee, and, pursuant to the Contribution Agreement ("Contribution Agreement") dated as of the date hereof by and between Assignor and Assignee, Assignor has agreed to transfer to Assignee the Division Assets, including Trademarks, defined as follows in the Stock Purchase Agreement:

"Trademarks" means all trade names, trademarks, service marks, logos, designs, trade dress and product configurations used or held for use by any Seller Entity or that relate to or are used or held for use by Seller in connection with the Business as presently conducted or proposed to be conducted, including, without limitation, all i) goodwill and common law rights symbolized thereby or associated therewith, and ii) all registrations and recordings thereof and all applications in connection therewith pending thereon in any state and in any country.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the parties agree as follows:

1. Assignor does hereby assign, transfer and sell unto Assignee:

(a) all right, title and interest in and to the Marks (including all claims for profits and damages by reason of past infringement of the Marks), together with the good will of the business symbolized by the Marks, and the registrations of the Marks and any applications for registration; and

(b) all right, title and interest in and to those Trademarks of Assignor other than the Marks that are part of the Division Assets.

2. Assignor agrees that, if at any time after the Contribution Closing any further action by Assignor is necessary to carry out the purposes of this Assignment of Blount Trademarks, Assignor will take such further action (including the execution and delivery of such further instruments and documents) as Assignee may reasonably request, at Assignee's sole cost and expense; provided, however, that Assignor shall bear all legal costs and expenses of its counsel and for recordings or other actions taken by them relating to title defects and/or Liens.

3. This Assignment shall be binding on the successors and assigns of the parties and shall inure to the benefit of their respective successors and assigns.

4. The parties agree that all capitalized terms used and not defined herein shall have the meanings ascribed to them in the Stock Purchase Agreement or Contribution Agreement.
